RULES FOR USE OF FIRE HYDRANTS:

- 1. No hydrant shall be used unless proper permits have been obtained from the City of Cleveland Water Department and the City of Solon.
2. Only proper tools are to be used on the hydrant. A hydrant wrench must be used. Pipe wrenches and crescent wrenches will not be tolerated.
3. The applicant shall be financially responsible for any and all damage which may occur while using the hydrant. The cost of repairs will be borne wholly by the applicant.
4. Vehicles are not permitted to drive over fire hose. However, if hose or water streams will affect traffic or safety on public properties or roads, the applicant must first notify the Solon Police Department for such an operation and provide a flagman, if applicable.
5. Deposits may be withheld or forfeited for failure to follow these rules.

Once the Cleveland Water Permit is obtained, return to Solon Fire Department with the paperwork for Solon Fire Department Permit issuance.

This permit will remain in effect for 60 days from the date of approval.
