



Dear Resident,

Thank you for your interest in the City of Solon Senior Rubbish Collection Program. This program is designed to provide curbside collection service of rubbish and recyclable to physically challenged seniors, 60 years of age or older, who meet the program criteria.

Criteria guidelines are as follows:

- Must be 60 years of age or older and physically unable to participate in the city’s curbside collection program.
- There can be no able-bodied person residing in the home or available to carry out rubbish and recyclables on your behalf.
- **Solid waste must be bagged and placed in the automated collection carts; this applies for both rubbish and recyclables.** Cart must be placed by the garage door (or alternate location designated during the in-home evaluation, and noted on this application) by 7:30 AM on your regular curbside collection day.
- **Yard waste bags or other large items do not qualify for the Senior Rubbish Collection Program and must be placed curbside.**
- Collection is **only** offered year-round and will not be offered on a seasonal basis.

In order for you to participate in this program you **must** complete and return this form, along with the attached Right of Entry Form to the Department of Senior Services, attention Solon Senior Center 35000 Portz Parkway, Solon, OH 44139. Contact the Solon Senior Center at 440-349-6363 with any questions. Please initial in the blank spaces below, acknowledging the following statements:

I understand and accept the program guidelines as stated above.

I am 60 years of age or more and physically unable to participate in the city’s curbside collection.

I have no able-bodied person available to take my collection cart to the curb on the scheduled day.

Right of Entry

In consideration of the City of Solon and/or its duly designated representatives, doing the work described herein, I do hereby agree as follows:

2. It is understood that, upon completion, the City of Solon and/or its duly designated representative will clean-up, restore, (reseed if necessary) and, in general, return the property as nearly as practicable to its original condition, taking into consideration the nature of the work performed.

Accordingly, it is understood that the City of Solon shall have no responsibility for maintaining the property in the future, except that the City will retain all responsibility for maintaining all inlet and outlet structures and any storm sewer pipes leading into or out of the detention basin. In addition, in the consideration of the City performing the above described scope of work, the undersigned, and their successors in interest, agree to maintain the work performed hereunder in the future.
4. The undersigned, and their successors in interest, agrees to indemnify, keep and save harmless the City and its respective officers, agents and employees against all claims, causes of actions, suits, liabilities, and/or damages that may be based upon any injury to persons or property that may arise out of any negligent act, error, or omission in the performance of the work being done hereunder.
